

TIMETABLE FOR JUNE 23, 2020 ELECTIONS

May, 22 or sooner if available	SBE – Establishment of a secure online portal that will allow voters to request an absentee ballot through submission of personally identifiable information. Section 5.
May, 22 or sooner if available	SBE will send non-forwarding postcard to every registered voter in the Commonwealth to inform them of changes to the 6/23/2020 election. Section 4 .
Now – June 22, 2020	Clerks’ offices and phone lines to available to schedule in-person absentee appointments. Section 10.
Now – June 23, 2020	Clerks’ offices and phone lines to available to schedule in-person Election Day appointments. Section 11.
Now - June 23, 2020 (6:00 PM)	Window for voter to return ballot to Clerk’s office or other approved location. Section 7.
May 15, 2020	Deadline for County Board of Elections to appoint precinct election officials for polling locations open on June 23. Section 12.
June 1, 2020	Deadline for County Board to appoint absentee ballot processing committee. Section 8.
No later than June 8, 2020 – June 22, 2020 (at least 5 days a week in the two weeks before June 23)	Clerks’ offices open for in-person absentee voting by appointment. Section 10.
June 1 - June 30, 2020 (6:00 PM)	Window for absentee ballot processing committee to meet and tabulate votes. Sections 8 & 16.
June 15, 2020 (11:59 PM)	Deadline for voter to request through online portal that absentee ballot be mailed to them from their County Clerk. Section 6.
June 16, 2020	Deadline for Clerk to mail a ballot to voter who has requested one. Clerk otherwise has 7 days to transmit ballot. Section 5.
June 22, 2020	In-person absentee results to be tabulated at end of business. Section 10.
June 23, 2020 ELECTION DAY	Postmark deadline for mail-in absentee ballots. Section 6. In person voting at polling sites 6AM – 6PM. Section 11.
June 16 - June 23, 2020 (6:00 PM)	Window for voter to request absentee ballot to be delivered outside of the postal system and/or picked up. Section 6.
June 23, 2020 (6:00 PM)	Reporting of results may begin. Section 8.
June 27, 2020 (6:00 PM)	Deadline for delivery of all mailed absentee ballots by USPS. Section 6.
June 29, 2020 (4:30 PM)	Deadline for signature cures. Section 9.
June 30, 2020 (6:00 PM)	Deadline to transmit vote totals to SOS. Section 16.
July 7, 2020 (4:00 PM)	Filing deadline for recanvassing. Section 17.
July 21-31, 2020	Public Hearing Window
July 31, 2020	Deadline for SBE to mail letter to in-actives asking if they have moved out-of-state. Section 15.
July 31, 2020	Public Comment Period Ends
